### After-school Learning and Support Programmes

In order to raise students' learning effectiveness and broaden their learning experiences outside classroom so as to increase their knowledge and sense of belonging towards society, our school has set up the "After-school Learning and Support Programmes" to assist students who are in need of financial assistance.

The Support Programmes include:

1. The Student Activities Support Grant provided by the Education Bureau.
2. The School-based After-school Learning and Support Programmes funded by the Education Bureau.
3. Shiu Wai Ming Financial Assistance Fund

The details of the supporting areas:

- Help poor students pay the fees for extra-curricular activities
- Let poor students have the chance to take part in local or overseas educational tours
- Provide grants for further studies

- Provide students from underprivileged families with maintenance grants
